By signing this document, I agree to hold **Mari Schurian** from liability relating to injuries, damages, costs loss or expenses (including without limitation, attorney fees) that may occur with **any** events related to the **Untamed Change Retreat in the Republic of Tonga, October 27th - November 3rd, 2017**. By signing this agreement, I agree to hold **Mari Schurian and the location** entirely free from any liability, regardless of whether injuries are caused by negligence.

I, as the Retreat facilitator, am not responsible for any of the participant's travel or flight arrangements. Notice is hereby given that if arrangements are made on behalf of a participant, they are made on the sole condition that the organizers or Retreat facilitator shall not be held responsible for any injuries, accidents, illness, death, delay, loss, damage, act of negligence, or irregularity. **Mari Schurian** acts only in the capacity as an agent for the participants in all manners connected with the resort "Serenity Beaches Resort" - accommodations and food, transportation by boat, bus, car or any other means. **Mari Schurian** relieves herself of all responsibility for any damage occasioned by any cause.

I am aware that I will lose a day when I fly from the United States to Serenity Beaches Resort, Tonga and that **my trip to Uoleva island can** therefore take up **to three days**. I take full responsibility for my travel planning and arrangements and will make sure that I have enough time to arrive on time for the Untamed Retreat on October 27th, 2017.

I also acknowledge there may be **risks** involved in **travel and any and all activities I choose to participate in**. These include but are **not limited** to bodily injury including death, theft, or injury from outside activities I chose, and travel issues. I agree to listen to my own body and common sense and work within my own limitations. It is **my responsibility** to never take any exercise or activity to a level of discomfort and pain. I am aware that the closest hospital is on the main island of Tongatapu, which is a 45 minute boat ride and a 30 minute flight away.

I affirm that I am participating voluntarily, and that all risks have been made clear to me. Additionally, I do not have any conditions that will increase my likelihood of experiencing injuries while engaging in any activities, including but not limited to meditative free dancing, swimming, snorkeling, boat rides, and walking on the sand on a beach.

By signing below, I forfeit all rights to bring a suit against **Mari Schurian** for any reason. I will make every effort to obey safety precautions as listed in writing and/or as explained to me verbally. I will ask for clarification and assistance when needed.

It is **strongly** recommended to purchase **Travel Insurance (Cancellation and Medical Insurance)** to protect against cancellation fees and additional travel expenses that may incur before, during and after your trip.

Required Documents

A **valid passport** must be held by each participant traveling internationally. Some countries require that your passport is valid for 6 months from your return date. Visas are required for entry into Tonga from some countries, such as South Africa. A visa on arrival (for 31 days) is required for citizens from the United States of America. You will get the visa at the airport as you land. Please check with your local Embassy or Consulate of the country being visited, to learn about Visa requirements for your Nationality. Obtaining visas is the participant's responsibility.

Included in the Retreat

The Retreat commences the moment you land at Serenity Beaches Resort on September 27th, 2017 and ends on the morning of November 3rd, 2017.

The **Retreat program is based on Biofield (Energy) Psychology techniques** (for more information visit my website at www.healyoursoulcore.com) and the results may vary from person to person. Therefore, no guarantees of result or performance are expressed or implied. The Untamed Retreat is intended to enhance relaxation and well-being, positive change, and to educate the participants about possible energetic, mental or emotional blocks that may create unease in certain areas of their lives.

I also understand that Mari Schurian operates as a Biofield Psychology Practitioner under California law SB 577. As such, I understand that Mari Schurian is not a licensed physician, but is instead an Integrative Biofield Psychology Practitioner who holds a Masters Psychology degree in Biofield Psychology. The healing treatment services Ms. Schurian provides are not licensed by the state of California but is alternative or complementary to the healing arts services licensed by the state of California. I, the undersigned (Retreat participant), voluntarily makes and grants this waiver, disclaimer and assumption of risk in favor of Mari Schurian as partial consideration (in addition to monies paid) for the opportunity to participate in the process/service provided, and /or to damages, losses and /or death that may arise from the aforementioned process.

Any dispute or claim arising between the parties to the agreement, which is not settled through mediation, shall be decided by neutral, binding arbitration, and not by court action (you give up your right to trial by jury), in accordance with the rules of either the American Arbitration Association (AAA) or Judicial Arbitration and Mediation Services, Inc. / Endispute (JAMS/ Endispute).

Cancellation Policy

To reserve your spot for the Retreat, please make a \$500.00 U.S. deposit by check / PayPal / Visa/. Check payable to : Mari Schurian.

The deposit is non-refundable.

Any cancellation will result in a total loss of the \$500 USD deposit, except when the retreat is canceled because it does not meet the trip participant minimum of 4 people. Then your deposit is refunded in full. Trip cancellation insurance is always highly recommended whenever making travel plans.

Any **cancellation** made **between September 13th, 2017 and September 18th, 2017** will result in a **loss of 50% of the trip price.**

Any **cancellation** made **between September 19th and November 3rd, 2017** will result in a **total loss of funds.**

Please note that there will be no refunds or discounts in the event of late arrival, early departure, flight cancellations, travel delays or illness. If you cancel your Retreat participation after September 13th, 2017 for any reason, the cancellation policy will apply.

To cancel, you must send **an email** stating that you **wish to cancel** from the Retreat to: **healyourcore@gmail.com.**

If I **cancel the Retreat** due to too few participants (4), I will refund to you all deposit and payments you have paid; less credit card /Pay Pal/ Bank processing fees. I cannot, however, compensate you for air or travel costs incurred.

Please note NOT to book and confirm any non-refundable flights and hotels before the Retreat is confirmed by and after September 13th, 2017.

In the unlikely event that I, Mari Schurian, must cancel the Retreat due to illness, an accident, weather, natural disaster or political upheaval, I cannot guarantee a refund - it will be dependent on receiving a refund from the venue. To cover the risks, I recommend, once again, you **purchase travel insurance.**

I wish I could compensate people for unforeseen circumstances (injury, family emergency, etc.), but I have costs already incurred when reserving and planning the Retreat. I have designed the cancellation policy to be as simple and compassionate as possible in the event that your plans change. To protect yourself further, I encourage you to **purchase travel insurance.**

Full payment:

When you **register** to reserve your place on the Retreat, you may **either pay in full or pay the deposit.** Upon receipt of your payment, I will send you a receipt and invoice for the balance, if any.

Full payment is due September 13th, 2017; unless otherwise noted.
